# State Championship and Sanctioned Tournaments Recap (Girls U16-U19) - Matt Rader

- The girls State Championships kicked off tournaments for the summer with 46 teams participating. The tournament completed with only one team that had to withdraw
- 10 sanctioned tournaments that cancelled
- 7 sanctioned tournaments that have occurred or currently running
- 7 remaining sanctioned tournaments for the end of the year

## <u>Summer Series Recap – Cindy Baron/Scot Boyd</u>

- 1,078 teams participated of the 1,483 teams anticipated to participate
- Overall hosting the summer series was a success.

#### Legacy Fields Update - Bryan Attridge

- Region 6 Shivwits development agreement signed, lease agreement almost signed, escrow account being prepared. Breaking ground very soon. Goal is to be playing on the fields Fall 2021/
- Region 2 Layton property owned and donated by Burton Lumber, 46 acres, 4 fields. Official donation is expected to be completed by December.
- Region 2 Discussion process for a handful of small sided fields at the Spence Eccles Sports Complex in Ogden.
- Region 1 20 acres, donated property in Logan

## Number of Games to Consider Fall season played - Cindy Baron/Scot Boyd

Cindy and Scot present to the board potential ideas for considering season completed based on any potential season interruptions. Concepts have been discussed with CS.

- Premier league must player 20% of their games for season to be considered completed
  - This is due to U15 teams that played flex games during winter 2019/2020
- SCL, IRL, XL must play 50% of their games +1 in order for season to be considered completed
- Anticipate having policy finalized after meeting with comp committee
- Points per game played vs total points played
- Goal is to have completed before season kickoff

# Continuing Education for Coaches and Mandatory DOC Meeting – Eric Landon

- Eric presents to the board additional education curriculum that would be required of all OM each year.
- Provide educational opportunities (up to 4 hours annually) for each coach in order to remaining in good standing with UYSA.
