<u>Recreation Jersey Program</u>: In an effort to grow grassroots soccer in Utah, UYSA has been meeting with sponsors to help subsidize the cost of jerseys for recreation programs.

<u>Legacy Field</u>: Working with Michelle and the committees more closely to help further the program

<u>Technology Platform</u>: Affinity Sports was recently purchased by Stack Sports. Brian Smith informed the board that we are looking at other vendors, reviewing their platforms, in an effort to find improved technology and pricing.

<u>Club Communication:</u> Goal to meet with all the clubs prior to the AGM. In the future USYA would like to continue meeting with clubs each year in an effort to collaborate and build

relationships. Brian Babcock suggests letting the region director know when we are meeting with the clubs within their region.

Eric Landon, Technical Director

<u>Hiring of Assistant Technical Director</u>: Would like to hire an assistant by June 1, 2020. A job description is written for the position. Applicant would be able to meet and collaborate with clubs.

<u>Club Standards/ Club Development program</u> The next meeting will be in February. The curriculum is geared toward helping Organizational Members with coaching development and curriculum.

<u>US Soccer Roadshow</u>: Provides coaching education resources for coaches to connect with member associations.

<u>Referee Recruitment</u>: Marketing (Video/Campaign) RSL Mentoring Program, RSL Scholarship funding with UYSA. Toby Yoshida mentioned that we need to have more headsets for referees. <u>Brian Smith</u> emphasizes the importance of needing more mentors. Matt Rader discussed the Club Lines man program and a program called iRef.

<u>Creation of Sponsor Material</u>- Working on creating more value to our members by drive more revenue to the association's programs.

<u>Anti-Racism Campaign</u>: Has been brought up by clubs. Working to create Kick Racism campaign. Create contests, pledges, petitions, sponsor to donate \$ for every pledge. Brian Babcock mentioned that we could show something at the AGM.

US Youth GRIP Report (Growth and Retention) – Bryan Attridge

Bryan Attridge explained chart that shows the GRIP Report presented at the US Youth workshops in Baltimore, which identifies trends, weaknesses, and opportunities as well as showing club retention rates. This service has been provided by US Youth Soccer to analyze player data for each club. The goal is to be able to help clubs grow their programs. This analysis is free to Utah Youth Soccer organizations.

US Youth Leadership Summit Initiatives/Updates - Brian Smith and Bryan Attridge

Bryan Attridge Talked about National Calendar and a shared resource center that will be provided for each state.

Brian Smith discussed the new futsal initiatives with US Youth Soccer. He has joined a committee with 6 other state presidents to organize regional and national futsal tournaments.

Matt Rader spoke on a few Presidents Cup incidents that are currently being addressed.
